Job Posting Continuing Care Assistant Full Time, Permanent

General Description

The Continuing Care Assistant will provide client care based on assessed needs. The successful candidate will work under the supervision of the Home Care Nurse Manager/Assessor (HCNMA).

Duties

To provide personal care as supervised by a Registered Nurse and according to the approved care plan. Personal care may include the following:

- Bathing and grooming
- Assistance with eating
- Simple bedside care
- Arrange routine foot and nail care
- Maintaining medical regimes
- Toileting
- Dressing
- Transferring
- Skin care
- Promoting self-reliance and motivation
- Monitoring vital signs (blood pressure, temperature, respirations, spot blood sugars) as directed by HCNMA and reporting pertinent results to supervisor.

To provide household management assistance to the client according to the care plan. These services may include the following:

- Menu planning
- Meal preparation
- Laundry, ironing, simple mending
- General house cleaning

To provide attendant services or respite according to the care plan of the client for one of the following purposes:

- Supervision of clients who cannot be left alone
- Provide care to the client so that the caregiver can be given a break so that he/she can continue giving care on a long-term basis
- Assisting the family to provide care for the terminally ill in the home











- Provide assistance with meal planning and preparation, demonstrating knowledge of the client's special dietary and cultural needs while adhering to Canada's Food Guide
- Promote the independence of clients by teaching either the client or the family self-care

Providing reassurance, emotional support and socialization to clients

Documentation:

- Maintain accurate records of the care given and health status changes observed in the clients
- Observations of changes or accidents are to be reported immediately to the supervisor
- Report any suspicion of abuse to their supervisor immediately

Qualifications

- Be punctual and reliable
- Maintain a healthy, addiction- free lifestyle
- Must be willing to take additional training
- Valid driver's license
- Reliable transportation
- Have a certificate from SIAST or other recognized institute in the Special Care Aide or Continuing Care Assistant program
- Maintain CPR/AED and First Aid certificates
- Training/certification as required
