## **Executive Overview**

The Ochapowace Nation Economic Development is dedicated to enriching the Ochapowace Nation by supporting Economic Development for Ochapowace citizens and to foster wealth creation and economic self-sufficiency. The Ochapowace Economic Development Fund will assist new and expanding businesses and the creation of new jobs that will contribute to the sustainability of the economy. Ochapowace citizens are required to submit sound business proposals/ventures for consideration.

## **1.0 General Provision**

The Ochapowace Economic Development Fund is not intended to serve as a major funding vehicle for new businesses capitalization.

In general terms the fund will be used for the following purposes:

- To assist the cost of preparing business plans (may be non-monetary)
- To assist in business start-up costs
- The capitalization and/or enhancement of small businesses



## **2.0 Objectives**

- To promote Ochapowace Nation citizens in business development
- To foster Ochapowace Nation entrepreneurs, cooperatives and corporate ventures
- To facilitate sound business planning and employment development
- To ensure effective financial management of Ochapowace Nation Economic Development funds
- To ensure accountability to the membership concerning Economic Development

## **3.0 Applicant Criteria**

- The applicant must be registered with Ochapowace Nation #71
- The applicant must be over the age of 18 or have proven expertise in business
- The business must be owned 51% by the Ochapowace citizen applying, assistance may be prorated to reflect ownership
- The applicant must not be indebted to Ochapowace Nation
- The business must clearly show benefit to the applicant, community or Nation citizens
- Businesses case/plan must be included with application
- Businesses must meet the standard legal requirements and not present any legal or financial liabilities to Ochapowace Nation
- Have not previously applied for and received assistance from the Economic Development Fund Grant/Loan Program

## 4.0 Funding

Costs directly related to certain capital investment will be considered for funding, including but not limited to, investments in physical or intellectual property.

Funding must be used to either establish a new business or expand existing business.

## **5.0 Compliance Measures**

Ochapowace Nation expects the funds granted will be used for the specific intended purposes as outlined by the applicant in the application. Applicants will be signing a legal contract (application form) with the Ochapowace Nation concerning the use of the grant/loan funds. Accordingly, the applicant bears 100% of the responsibility for the proper use of these funds. The Ochapowace Nation carries no responsibilities and carries no legal or financial liabilities related to the use or management of these funds.

The following compliance measure applies:

- Grants not used for its intended purpose shall be repaid by the applicant
- An applicant who has an outstanding debt to the nation and/or has a history of default or none payment will not be eligible
- An applicant who has received a grant/loan with the nation will not be eligible for any new grant for the same/existing business or venture



## 6.0 Financial Availability

Assistance is available for ONE of the following business venture requirements:

- small business start-up Business plan, capital equity and/or operating costs
- Business Enhancement for capital equity and/or operating costs

## 7.0 Grants

- Funding options can be performed in a grant
- Grants do not have to be repaid provided the applicant is in compliance with the terms and conditions of the Economic Development Fund guidelines
- Grant funding to any one project will not exceed \$20,000 (twenty thousand dollars)

## 8.0 Eligible expenditures

Will include, but are not limited the following:

- Development and distribution of marketing and promotional materials
- Legal accounting or other professional fees related to the project
- Specialized equipment necessary for the project
- Feasibility and business plan preparation
- Costs of obtaining technical expertise
- Consultants/subcontractors
- Small capital improvements of business

Eligible expenditures shall NOT include:

- Land, buildings and infrastructure
- Debt restructuring or fundraising
- Direct wage subsidies
- Criminal enterprise

Eligible expenditures must be directly related to the project – expenditures must be actual cash outlays that are documented through paid invoices and receipts. Proof of applicant ability to cash flow this project should be required.

## 9.0 Assent and Approval
